

UAB NORDSTREET PRIVACY POLICY FOR INVESTORS

UAB Nordstreet takes care of the protection of your information. We comply with the European Union's General Data Protection Regulation (GDPR) and other laws protecting your information that we collect, use and store in our Company.

1. How should I read this Privacy Policy?

This Privacy Policy will answer the most important questions about how we collect, use and store information about you. If you have any questions or are unclear about any part of this notice, we are available to assist you as described in Section 13 of this Privacy Policy. Please note that any form of the word "we" in this Privacy Policy refers to our Company as set out in Section 2 of the Privacy Policy.

2. Who is responsible for protecting my information?

3. Why are you collecting information about me?

By registering on our managed crowdfunding platform, you have entered into a contract with us for the use of the Nordstreet platform. We collect, use and store your data for the following reasons:

- so that we can execute this contract and enable you to properly use our crowdfunding platform;
- to enable us to fulfill our legal obligations related to money laundering and terrorist financing prevention requirements;
- for statistics - we collect aggregated and anonymized information about invested amounts, financed loans and similar criteria for using the crowdfunding platform. You can find more information by clicking [this link](#).

4. What information should I provide you and why?

In order to register on our crowdfunding platform and invest in it, you must provide us with: identification data (name, surname, date of birth);

- the country where you live;
- contact data (e-mail address, phone number);
- information about investment experience (obtained by filling out the questionnaire).

5. Do you collect information about me from other entities?

You can invest on our crowdfunding platform only after opening an account with the company "NS Pay", UAB, therefore we can receive information about you from this company related to your identification, which we need in order to properly fulfill the requirements for the prevention of money laundering and terrorist financing.

6. What is the legal basis for collecting information about me?

We collect information about you legally, because your information is necessary:

- to conclude and execute a contract with you (GDPR, Article 6, d. 1, p. b);
- to fulfill legal obligations in tax, accounting, prevention of money laundering and terrorist financing and other areas (GDPR Article 6 d. 1 c p.).

7. Are you collecting sensitive information about me?

Sensitive information about you is not collected.

8. Do you make automated decisions? Are you profiling me?

No automatic decisions are made. We may perform profiling actions on you if you consent to at least one of our direct marketing tools. More information about this can be found in the privacy policy for recipients of our direct marketing content.

9. Are you sharing information about me with anyone?

When processing your personal data, we may transfer it to the following data recipients:

- to state and local self-government institutions (e.g. the Bank of Lithuania, etc.), in those cases and to the extent provided by legal acts;
- for project owners, to the extent necessary for the project owners to fulfill their tax obligations;
- to our service providers, for example: companies providing accounting, archiving, communication, data storage, information management systems and similar services that undertake the confidentiality and security obligations provided for by legal acts in the field of personal data protection;
- to companies providing legal services, law firms, when it is necessary for the defense of our legitimate interests;
- for public or private persons performing audits or inspections, undertaking non-disclosure obligations.

10. Do you transfer information about me outside the European Economic Area (EEA consists of all EU member states and Norway, Iceland and Liechtenstein) boundaries?

Information about you is not transferred outside the European Economic Area.

11. How long do you keep information about me?

Information about you, related to the execution of the contract and the fulfillment of the legal obligations applicable to us, will be stored in accordance with the procedure established by the Regulation of European Crowdfunding Service Providers and the Law on the Prevention of Money Laundering and Terrorist Financing - 10 years from the date of conclusion of the financing transaction or 8 years from the business relationship with you (please note that in the case of receiving an instruction from the competent authorities, this deadline can be extended for an additional period of 2 years), depending on which deadline will come later.

12. What are my rights?

If you wish to take the steps below, please contact us as set out in section 13. Please note that these rights are subject to statutory conditions and exclusions.

- **Submit a request to get acquainted with the available information about you, if we process your personal data from which we can determine your identity;**
- **submit a request to correct or supplement available information about you; □submit a request to delete about you when:**
 - **We process your data on the basis of consent; ohWe process your data illegally;**
 - **Your data is processed on the basis of our legitimate interest and you dispute our legitimate interest;**
 - **Your data is no longer necessary to achieve the purposes for which it was collected; ohwe are under a legal obligation to delete information about you;**
- **submit a request to us to limit the processing of information about you when you dispute the accuracy of the data or object to the processing of data, you do not agree to the deletion of your illegally processed data, or you need the data in order to assert, fulfill or defend legal claims;**
- **dispute the collection, use and storage of your information in our company, when processing your data we follow legitimate interests as the basis of data processing;**
- **submit a request to export your data if you have provided us with the data in a structured, commonly used format and have given your consent to the processing of such data or we need to process this data in order to fulfill a contract with you;**
- **submit a complaint to the State Data Protection Inspectorate (more information vdai.lrv.lt).**
