  - iii. **Your data is no longer necessary to achieve the purposes for which it was collected;** we are under a legal obligation to delete information about you;
- c. **submit a request to us to limit the processing of information about you when you dispute the accuracy of the data or object to the processing of data, you do not agree to the deletion of your illegally processed data, or you need the data in order to assert, fulfill or defend legal claims;**
- d. **dispute the collection, use and storage of your information in our company, when processing your data we follow legitimate interests as the basis of data processing;**
- e. **submit a request to export your data if you have provided us with the data in a structured, commonly used format and have given your consent to the processing of such data or we need to process this data in order to fulfill a contract with you;**
